16:45 BayWa: With SAP Central Finance to SAP S/4HANA **MATTERHORN**

The agricultural group BayWa switched to SAP S/4HANA and implemented SAP Central Finance as a central part of the changeover. The go-live of the switch to SAP S/4HANA was at the beginning of 2024. With the introduction of SAP S/4HANA, the Group replaced a very heterogeneous SAP R/3 system that was around 20 years old. SAP Central Finance connects the old SAP R/3 system with the future SAP S/4HANA system and thus enables a gradual move with cutting patterns across the legal structures, significantly reducing complexity and risk in particular. At the Accounting Summit, Tobias Fausch and André Schwarz will report on the preliminary study carried out in advance and provide a practical insight into the subsequent implementation and the particular challenges of the project.
